# Terms of Reference (ToR)

# "Preventing minors from illicit drug abuse through identifying the risk factors and their mental health condition: Bangladesh perspective"

1. Background: Bangladesh is a role model of many countries in context of achieving Millennium Development Goals (MDGs). Presently Bangladesh is facing challenges in preparing plan to achieve the SDG's Target 3.3<sup>1</sup> and Target 3.3<sup>2</sup>. Moreover, Addiction to illicit drug by the under aged population i.e., minor is reported in the local<sup>3</sup> and foreign<sup>4</sup> media.

Today, there is no country in the world free from the aggression of drug abuse <sup>5</sup>. Bangladesh is not exceptional rather the expansion and use of drugs come into a horrible state in here. This terrible image is not only attacked the adult figure but also the immature child or youth figure. According to National Institute of Mental Health and Hospital (NIMH), a survey (2009) had been conducted by NIMH titled "Prevalence of mental disorders, mental retardation, epilepsy and substance abuse in children". In this survey, they have found that Substance Related Disorder (SRD) among children in Bangladesh is 0.8%. As drug is not only damage a person's life but also it destroys a whole family, society and the system of a country. That is why the government of Bangladesh has adopted zero tolerance against drug abuse to come out from the curse as well as this evil situation.

Drug use in early stage can affect development, and children who use drugs are at higher risk of health harms. Moreover, initiation of drug use in adolescence can lead to longer-term use and dependence more readily than initiation in adulthood. So, this study will deals with causative and factors of child drug users, reason for their addiction, drug dealing, involving drug trade and problems caused by them, danger of drug abuse, legal

### 2. Objective of the Study

**2.1 Broad Objective of the study:** The objective of the study is to identify underlying risk factors why children are being addicted by illicit drug use as well as indentifying their mental health conditions by which their being attracted to be introduced with drug..

### 2.2 Specific objectives:

- Providing an overview of the current status of drug abuse among minors including their socio-demographic information;
- Identifying risk factors of drug addiction and drug abuse among minors and major challenges to prevent such abuses;
- Figure out the relationship of peddlers with the children for carrying and selling illegal drugs;
- Identifying mental health condition of drug abused children.
- Find out consequence of minors' drug addiction in their family and society;
- Analysis of strategic priorities of GO-NGOs to prevent minors' drug abuse based on the need and challenges indentified by them.
- Provide recommendation on role of Department of Narcotics Control to prevent minors' drug abuses.
